| VI. Youth Peer<br>Support<br>curriculum<br>presentation                                    | Kim Nabarro (Co-Facilitator) introduced the Youth Partner Group, who will share their curriculum presentation.  EPIC 'Ohana has been closely working with the Child and Adolescent Mental Health Division at the Department of Health to establish a credentialing and certification system for youth peer support specialists. Corinna Sosa and Janae Davis shared their process, including supervision and support for youth peer support specialists.  Quorum was lost after the presentation, therefore the remaining agenda for the meeting was halted, but the floor was opened to questions regarding the presentation.  Tia Hartsock thanked the presenters for sharing and asked them what lessons they learned along the way, and if they are considering translating the youth model into an adult or family support model. with lived experience throughout the whole process.

Cynthia Chappell asked if the curriculum could be adjusted to be culturally relevant.

Corinna Sosa responded by saying that they have been working closely with the Karma Aloha team and with Venus to adopt their curriculum to include Native Hawaiian values and practices.

Cynthia Chappell asked if they are starting on a second cohort or if they are using a rotation and timeline for their cohorts.

Corinna Sosa stated that summer is the best time for training since they are working with college students.

Kathy Hammes uplifted the presenters and asked them if they have specific goals regarding the number of people trained, as well as the number of people who continue with the program.

Corinna Sosa said that their goal is to support as many youth as possible, such as assisting with the development of their own peer support program.

Tia Hartsock (Chair) adjourns the meeting at 11:13 a.m. due to the loss of quorum.
